Dear Mr. Werth:

Please be advised that I represent Ms. Heidi Abbott. My purpose in writing this letter is to clarify certain misconceptions that you may have regarding your relationship with my client.

First, my client has terminated her business relationship with you. You must discontinue any further attempts to communicate with my client by telephone, personal messenger, computer, personal letters, etc. If you do not comply with this request, my client will seek the appropriate court orders restraining you from contacting her.

Second, my client is concerned with her contractual relationships with Omega Organization International and Affinity, the two company names you operate under. Both of those companies were checked through Washington State Secretary of State's Office for Corporation Information. Neither of those companies are listed as corporations in the State of Washington. In addition, both company names were checked through the Washington State Department of Revenue. Neither company appeared to be registered with the Department of Revenue. Further, neither company had a registered agent or registered agent address in the State of Washington, in violation of state law. Furthermore, both company names were also checked through King County and the City of Seattle Business License Records. Again, neither company appeared to be licensed in King County or Seattle, in violation of state law.

Based upon the above information, it is clear to me that you misrepresented and defrauded my client when you entered into contractual relations with her under this corporate name. Therefore, any contracts signed by my client with Omega Organization International or Affinity are void and voidable. Thus, my client hereby voids all contracts executed between her and Omega Organization International and Affinity.

Third, my client has the right to bring a cause of action for misrepresentation and fraud against you. Your fraud and misrepresentation could also amount to a criminal charge. However, my client simply wishes to discontinue all further contact with you and to have you return all videos of her that have been taken by you, together with any contracts signed by her.

To avoid any further action on the part of my client, please mail to this office <u>all videos</u> that have been taken since 1995 by you of my client. All videos must be received by Friday, January 15, 2000. My client has provided me a list of video and releases with the appropriate date and the appropriate event. If you fail to send <u>all videos</u> that you have of my client, I will advise her to proceed with civil and criminal charges against you.
